BYLAW NO. 2010-02

A BYLAW OF THE TOWN OF LANGHAM TO CLASSIFY, LICENSE, REGULATE AND GOVERN BUSINESSES

The Council of the Town of Langham, in the Province of Saskatchewan enacts as follows:

1) INTERPRETATION

In this Bylaw the expression;

“Town Administrator” means the Town Administrator of the Town of Langham,

“Council” means the Council of the Town of Langham,

“General Contractor” means and includes any person or persons who contract or covenant to do anything for another person or persons specifically, or who makes a business of executing work according to contract;

“License Inspector” means a person appointed by Council to carry out the duties of a license inspector as required by this bylaw,

“Sub-Contractor” means and includes any person or persons who contract or covenant to do anything for another general contractor or sub-contractor specifically;

“Transient Trader” has the meaning ascribed thereto by The Urban Municipality Act.

“Home Occupations” means and includes the following:

- Businesses based in a residential property
- Businesses owned and operated by residents of the Town of Langham which operate within the Town but maintain no office outside of this residence.
- Catering groups based in a home, church, or school when catering to other than their own base group functions.

2) DUTIES OF THE LICENSE INSPECTOR:

The License Inspector shall:

- a. Attend and/or report to all meetings of Council or a Committee of Council, whenever requested to do so or when he may find it necessary to do so, on matters connected with the duties of his office;
- b. Prepare a classified alphabetical list of all parties liable to take out a license and to use all diligence to have the same correct and submit the same monthly, or as often as required, for examination and use by the Town Administrator;

- c. Keep a register containing the names of all persons applying for licenses, the names of all persons to whom licenses have been granted or refused, together with, in the latter case, the grounds for refusal;
 - d. Advise the Town Administrator of all matters incident to his office;
 - e. Make an inspection of all premises in connection with which a license is sought and to make any inquiry with reference to matters relating to the granting of licenses requisite to securing due observance of this Bylaw;
 - f. Prosecute all person guilty of offences against this Bylaw and to be vigilant and active in the discharge of his duties;
 - g. Visit as often as is necessary all houses and premises, the owner or occupants of which are licensees under this Bylaw, to ascertain from time to time whether the persons licensed under this Bylaw continue to comply with the provisions of this bylaw, whether the premises licensed continue to remain in such a state that the Bylaw requires.
- 3) The fee payable for a license under this Bylaw shall be in accordance with Schedule "A" annexed hereto and forming part of this Bylaw or as the Schedule "A" may be amended from time to time by Council Resolution. Fees are payable to the Town by the Licensee or his/her legal representative and are due at the time of License application.
- 4) The Town Administrator is hereby authorized to issue a license to any person, or persons carrying on business in the Town;
- a. Who is not assessable by the Town for the purpose of business taxation in respect to that business; and
 - b. Who makes application for such license stating specifically the nature of his business in the Town; and
 - c. Who has complied with the Auctioneers Act if the same applies or may apply in respect of the license for which he has made application under this Bylaw; and
 - d. Who tenders with his application the proper license fee as herein provided for.
- 5) Subject to the right of Council to suspend or revoke the same as provided by The Urban Municipality Act, every license issued hereunder shall remain in force and effect until and including the thirty-first day of December of the year of issue.
- 6) Every license issued hereunder shall specifically state the kinds of service, goods, or merchandise which the licensee is authorized to offer for sale or take orders for as the case may be and whether in the case of goods or merchandise, he may offer the same sale by retail or by public auction or both.

- 7) No person to whom a license has been granted under this Bylaw shall offer for sale services, goods or merchandise or solicit orders for future delivery of goods or merchandise within the Town:
- a. Other than the kind or kinds described in the license; or
 - b. By any method except as authorized therein; or
 - c. At any time or during any period when shops within the Town offering for sale or taking orders for similar services, goods or merchandise are required by Town Bylaw to be and remain closed.
- 8) Every person licensed under this Bylaw shall, at all reasonable times, upon request of the Town Administrator, the license inspector or any peace officer, produce such license for inspection purposes.
- 9) Any person who violates any provision of this Bylaw is guilty of an offence and shall be liable on summary conviction to a fine of not less than \$100.00 and not exceeding \$1,000.00 and costs;
- a. In the case of conviction under the provisions of this Bylaw the convicting justice shall order payment of the required license fee and compliance with any other provisions of this Bylaw in addition to the penalty.
 - b. A person who fails within the period specified in an order under subsection a) to comply with the order is guilty of an offence and is liable on summary conviction to a fine not less than \$10.00 or more than \$50.00 for each day during which the breach continues.

Bylaw No. 2008-01 is hereby repealed.

- 10) This Bylaw shall come into force and take effect on the date of its passing.
